# The One-Cent Local Option Sales Tax and What it Means

- Dallas Center residents, along with the rest of Dallas County, will have the opportunity to vote on November 7 as part of the Regular City Election on a countywide referendum for a one-cent local option sales tax. The tax would be collected (in the cities that approved it) on a countywide basis and distributed to communities (only the cities that approved it) through a formula based on population and prior taxable valuations. Dallas Center would receive a projected \$287,000 annually from the local option sales tax.
- Here's what will appear on the ballot: "SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED? Summary: To authorize imposition of a local sales and services tax in the City of Dallas Center at the rate of one percent (1%) to be effective on July 1, 2018. Revenues from the sales and service tax shall be allocated as follows: 25% of such revenue to be allocated for property tax relief. The specific purpose for which the revenues shall otherwise be expended is 75% for additional local property tax relief and utility services relief through city expenditures for the construction of capital improvements, and the construction and maintenance of streets, sidewalks, water and sewer and storm water facilities, infrastructure, and parks and other recreational facilities in the City of Dallas Center to be effective on July 1, 2018.

## **City Tax Levy Information**

- Some citizens have contacted City Hall asking about increases shown on property tax statements, the 20% references the **total revenues** (tax dollars) collected by the City through property taxes. **That does not mean that the individual taxes of residents increased by that amount,** because there are other components of the total tax dollars collected such as increased property valuations made by the County, changes in the state-mandated "roll-back", and the addition of new properties to the tax rolls that were not taxed last year, all of which are out of the Council's control. Additional information about the City budget is shown on the enclosed insert. **In short, new houses and businesses = more tax dollars to the city.**
- The City Council voted to approve a budget that set the city tax levy at \$13.67722 per \$1000 of taxable valuation (previous city tax rate was \$12.53504/\$1,000). This happened to be an increase of \$1.14218 per \$1,000. This increase was specifically collected to pay this year's debt service on the SW Stormwater Project, Phase 1, in the amount of \$196,040, an important and necessary project the City has been planning the past five years.

#### Winter Reminders~

**Streets-**During snow events when plowing will be necessary, please remove all vehicles from City streets, alleys or City owned off-street parking areas. Vehicles parked in the street may be fined, towed or both. The parking ban will continue from the beginning of a snowfall to 24 hours after the snowfall has ceased.

**Sidewalks-**you have 24 hours after the snowfall to clear your sidewalk or the City may do so and bill the property owner.

Fire Hydrants-it is property owners' responsibility to clear the snow away from hydrants.
