**Dallas Center City Council**

On February 5, 2021, Iowa Governor Kim Reynolds issued an updated Proclamation of Disaster Emergency, which among other matters, encouraged all vulnerable Iowans to limit their activities outside of their home including their participation in gatherings of any size and any purpose. The Governor further continued the suspension of state laws requiring a public meeting or hearing to the extent the laws could be interpreted to prevent a governmental body from limiting the number of people present for an in-person location of the meeting, providing the governmental body provides a means for the public to participate by telephone or electronically. Compliance with the social distancing requirements for a public meeting would unduly limit the public's participation at a meeting of the City Council. As permitted by Iowa Code Section 21.8 the City Council meeting will be conducted by electronic means. The public is encouraged to access the meeting electronically in the manner specified below.

**RESOLUTION NO. 2021-11**

**A RESOLUTION APPROVING THE MAXIMUM PROPERTY TAX DOLLARS  
FOR FISCAL YEAR JULY 1, 2021 TO JUNE 30, 2022,  
FOR THE CITY OF DALLAS CENTER, IOWA**

**WHEREAS**, the City Council of the City of Dallas Center has considered the proposed Fiscal Year 2021-2022 city maximum property tax dollars for the affected levy total; and

**WHEREAS**, a notice concerning the proposed city maximum property tax dollars was published in the Dallas County News on February 11, 2021, as required and was posted on the City's website and social media accounts; and

**WHEREAS**, the City Council held a public hearing concerning the proposed city maximum property tax dollars on February 23, 2021.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY DALLAS CENTER, IOWA** that the maximum property tax dollars for the affected tax levies for Fiscal Year 2021-2022 shall not exceed the following total:

Total maximum levy for affected property tax levies - \$939,342

**IT IS FURTHER RESOLVED** that the Maximum Property Tax dollars requested in the total maximum levy for affected property tax levies for Fiscal Year 2021-2022 does represent an increase of greater than 102% from the Maximum Property Tax dollars requested for Fiscal Year 2020-2021.
