The enclosed drawing shows MidAmerican Energy Company's proposal for providing gas to serve 120,000 BTU with one (1) meter at the above location. The applicant charge for this installation is **\$1,275.30**. This proposal is valid for 90 days and if MidAmerican Energy Company construction has not commenced within 12 months it may be voided. This proposal is based on the following terms:

MidAmerican Energy Company Proposes To:

- 1. Furnish and install gas service piping of the appropriate size to serve the above load.
- 2. Furnish and install applicable gas meter.
- 3. Supply 10" WC
 - a. For a 10" WC, the customer's piping system must be able to receive, withstand and control 1lb. of pressure.

The Applicant Agrees To:

- 1. Be responsible for all restoration.
- 2. Provide without cost to the Company such easements as are necessary for the installation and maintenance of Company's facilities on private property. If a 3rd party easement is required any cost associated in obtaining the easement will be paid by the applicant.


