Hello all! I was very pleased to see the overwhelming support for our 3 incumbent Council Members (Ryan Coon, Danny Beyer and Ryan Kluss) in our November election. Thank you for your continued support. Having said that, I would now like to share a list of some of the things the Council and City have accomplished recently:

- ✓ The Fairview Sewer Extension to Hwy 44 which will allow the new Dollar General store to receive service.
- ✓ 2019 street asphalt overlays of Percival, Cherry and Vine in the southwest section
  of town.
- ✓ Public Works purchased a new snow plow of which the funding came from savings.
- ✓ The Fire Department will be purchasing new air packs and retiring their current packs after a long and useful life. The funding for this coming from savings.

## Upcoming projects:

- ★ A storm water extension on Hatton Street has been bid and approved with work starting in 2020.
- ★ The sewer treatment plant upgrade project to meet cleaner DNR water quality standards has been approved and construction started in December of 2019. The project is to be completed by the end of 2020.
- ★ A new well for drinking water to be drilled in 2020.
- ★ The 2020 street asphalt overlays on Sycamore funded with Road Use Tax Revenues as allowed.
- **★** Capital Improvement planning for the next 5 years is underway.

Dallas Center continues to be a vibrant community progressively looking toward the future. The Council and I are proud of the work that has been accomplished and look forward to the work to come!

#### Community News~

- Dallas County Health Department Information: January is National Radon Action Month. Iowa has the highest percentage of homes in the nation with radon levels above 4pCi/L. Radon is an odorless, colorless, and tasteless gas that can build up in your home. After smoking, it is the second leading cause of lung cancer in the United States. Testing your home is easy and inexpensive. Radon test kits can be purchased through the Dallas County Health Department website for only \$8. https://bit.ly/2PUugML
- ❖ Summer Pool Manager: Responsible adult with excellent leadership and communication skills, American Red Cross Lifeguarding/First Aid, CPR for the professional rescuer certification (must be updated within the past year). Responsible for managing aquatic facility operations including, but not limited to, supervising the assistant managers and lifeguard team, maintaining the facility, and planning and conducting in-service training. Deadline is January 31st.
- SAILDC If your family needs help, call SAILDC at 515-344-2074 for rides or snow removal.

#### Winter Reminders ~

- Snow Parking Ban It is unlawful to park, abandon, or leave unattended any vehicle on any public street, alley or city-owned off-street parking area during any snow removal period. The ban shall continue from the beginning of the snowfall to 24 hours after the snowfall has ceased.
- ♦ Sidewalks Snow and ice removal from sidewalks is the responsibility of the property owner. Residents are required by ordinance to clear sidewalks within 24 hours of the end of a storm. Please pile the snow on your yard, not in the street.
- ◆ Fire Hydrants The Fire Department requests property owners who have a hydrant on their parking area to clear the snow away for easier access in case of fire
- ♦ Thank you for your cooperation!

#### Pet Licenses are required ANNUALLY in January

- → Purpose for identification if pet is lost, to prevent pets from being destroyed as stray, and as a way of tracking vicious animals.
- → Registration every dog or cat shall be registered with the City prior to January 31st of each year.
- → Application Requirements provide proof of current vaccination against rabies, state breed, sex, age, color and name of dog or cat, and address, telephone, and signature of owner.
- → Registration Fees license fee is \$5.00. If the animal is not spayed or neutered, the fee is \$20.00 each. A \$5.00 late fee will be imposed on each dog or cat not registered by February 1st of each year.
- → Impoundment registered animals found at large are subject to a municipal infraction of \$100.00-1st offense, \$200.00-2nd offense, \$400.00-3rd offense, \$625.00-4th offense. Unregistered animals or registered animals found at large on more than three (3) occasions shall be seized and impounded. Impounding costs are \$200.00.
- → Tags will not be mailed unless a pre-stamped envelope is included with the application.
