City Tax Levy Information

- Some citizens have contacted the city regarding increases shown on property tax statements, the 6.54% references the total revenues (tax dollars) collected by the City through property taxes. That does not mean that the individual taxes of residents increased by that amount, because there are other components of the total tax dollars collected such as increased property valuations made by the County, changes in the state-mandated "roll-back", and the addition of new properties to the tax rolls that were not taxed last year, all of which are out of the Council's control. In short, we are fortunate to be a vibrant, growing community and new houses and businesses = more tax dollars to the city.
- In March 2019, the City Council voted to approve a budget that set the city tax levy at \$12.67557/\$1000 of taxable valuation (previous city tax rate was \$13.35773/\$1,000). This happened to be a **decrease** of \$.68216 (approximately 5%) per \$1,000.

Winter Reminders~

Streets-During snow events when plowing will be necessary, please remove all vehicles from City streets, alleys or City owned off-street parking areas. Vehicles parked in the street may be fined, towed or both. The parking ban will continue from the beginning of a snowfall to 24 hours after the snowfall has ceased. Sidewalks-you have 24 hours after the snowfall to clear your sidewalk or the City may do so and bill the property owner. Fire Hydrants-it is property owners' responsibility to clear the snow away from hydrants.

Don't forget to license your pets annually (before February 1, 2020). Renewals for 2020 are now being accepted at City Hall. Be sure to bring current rabies vaccination as we will not issue a license without this.
